

ORDINANCE NO. 1377

SECTION XVI, ARTICLE 2. SECTION 16-201 ZONING AND SUBDIVISION REGULATIONS, INCORPORATED BY REFERENCE IS HEREBY AMENDED, BY AMENDING SECTION 22, "SPECIAL USES", BY GRANTING A SPECIAL USE TO CERTAIN PROPERTY IN THE CITY OF TONGANOXIE, KANSAS, FOR A CHILD DAY CARE FACILITY.

WHEREAS, under the ZONING ORDINANCE AND SUBDIVISION REGULATIONS OF THE CITY OF TONGANOXIE, KANSAS, 2003, the Governing Body of the City of Tonganoxie, Kansas, is given the power to amend, supplement or change existing zoning regulations or grant special use permits within the City; and

WHEREAS, the City Planning Commission, after fully complying with the requirements of the ordinances of the City of Tonganoxie, scheduled a public hearing which was held on the 5th day of June 2014, at 7:00 P.M., in the Tonganoxie City Council Chambers, the official date set out was published in the Tonganoxie Mirror newspaper, and

WHEREAS, upon a motion made and duly seconded and passed, the Planning Commission resolved to grant a renewal of a special use permit in the R-SF "Single Family District" for an in-home day care located at 102 N. Village Terr. on the following described property, to wit:

Lot 8, Oroke's Subdivision to the City of Tonganoxie, Kansas according to the recorded plat thereof, in Leavenworth County, Kansas more commonly known as 102 N. Village Terr.

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF TONGANOXIE, KANSAS:


SECTION 1. The above described property being in an R-SF "Residential Single Family District", is hereby granted renewal of a special use permit for an in-home child day care with the following conditions:

- a) Conditional approval on submittal of final KDHE permit to the City. If not presented by expiration of temporary permit, the SUP will expire at the end of thirty days after the expiration of the temporary permit (8/27/2014)
- b) The special use permit shall be valid for a period not exceeding five (5) years after approval by the City Council and the publication of the Ordinance which grants the special use permit
- c) The applicant shall notify the City of any changes to the license granted by KDHE for the child day care center on the subject property.
- d) The applicant shall obtain a fire inspection on an annual basis concurrently with the annual renewal of a City Business License for the day care center.
- e) The daycare shall be operated in conformance with the Kansas Department of Health and Environment as submitted with this application. The owner shall notify the city if any changes are made to the State for any licensing other than for childcare.

f) Any building mounted or on-site signage associated with the business must be in accordance with Section 25-015 (Signs Permitted in Residential Districts) of the Zoning Ordinance. Any new signage shall require a sign permit prior to installation.


